Last year, we asked the community to review and update its contact information for our directory. Unfortunately, the hard drive that stored this updated information had an electronic malfunction and was wiped clean. So, we are starting again from scratch.

With this dues notice we are trying to accomplish multiple tasks:

1. Compile accurate information for all of our members for this year's directory
2. Clean up the email addresses in our Google Group listserve. We have over 600 email addresses in our database, but no record of who they belong to. As a result old e-mail addresses that are no longer active and those of individuals who no longer live in Stoneleigh continue to receive e-mails from the community association. With this notice, we are going to delete the inactive addresses.

If you are not a member of our listserve, I strongly encourage you to become one. The email addresses in this system are ONLY used for Community business. Access to these addresses are limited to the Community Association President and Vice President. We do NOT give them to outside third parties and make every effort to limit the number of emails you will receive.

3. Some of our community association members do not have internet or email access. We would like to find out who these residents are. In the future, we would like to become more environmentally friendly and will try to email many of the notices that we may have printed out in the past. But before we do this, we want to know who among you does not have internet or email access so we can print out the electronic notices and have them delivered to your house. We want to make sure every member of the Community Association is properly informed of community events while at the same time doing what we can to protect our environment.

4. We have also had received requests to add additional information to the directory, namely email addresses and cell phone numbers. While I can understand that not everyone will want this information published, some of you clearly do. No one is being forced to give out or publish any information that they do not want to make public. As you will see on the form on the other side of this piece of paper, we have included a box which asks whether or not you would like this information in the directory. Please check the appropriate box.

Your Community Association dues fund programs and projects such as greening and recycling, Citizens On Patrol, neighborhood communications like the *Stoneleighite* newsletter, the association's website, distribution of flyers, the Stoneleigh Directory, and a variety of other activities and programs that enhance neighborhood quality and property values.

Dues do not fund social activities or the pool, both of which are self-funding.
